

RESOLUTION NO. 2011-

A RESOLUTION SUBMITTING THE QUESTION OF AN ADDITIONAL TAX LEVY FOR THE PURPOSE OF PROVIDING FUNDS TO PAY COSTS OF IMPROVING THE MUNICIPAL ROADS AND BRIDGES PURSUANT TO REVISED CODE SECTION 5705.191, AND DECLARING AN EMERGENCY.

WHEREAS, the Village of Perry, Lake County, Ohio, two-thirds of all members elected thereto concurring, that:

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF PERRY, LAKE COUNTY, STATE OF OHIO:

Section 1. That it is hereby found, determined and declared that the amount of taxes which may be raised by the Village of Perry, Lake County, Ohio, within the ten-mill limitation of the current tax duplicate will be insufficient to provide an adequate amount for the necessary requirements of this Village, and it is necessary to levy a tax in excess of such limitations for the purpose of providing funds to pay the costs of rehabilitating, renovating and otherwise improving municipal roads and bridges at the rate of **one and one-half (1.5)** mills for a period of five years.

Section 2. That the question of **an additional** tax levy of **one and one-half (1.5)** mills upon the tax list and duplicate for five years, beginning with the **2011 tax list** and duplicate and with the first distribution of the proceeds of said levy to this Village in **the calendar year 2012**, for the purpose of providing funds to pay costs of rehabilitating, renovating and otherwise improving municipal roads and bridges under the provisions of Ohio Revised Code **Sections 5705.19** and **5705.191** be submitted to the Electors of the Village of Perry at the general election to be held therein on **November 8, 2011**, as authorized by law, and said election shall be held at the regular places of voting in said Village as established by the Board of Elections of Lake County, Ohio, or otherwise, within the time permitted by law and shall be conducted, canvassed, and certified in the manner provided by law.

Section 3. The form of ballot to be cast at such election on the question of such tax shall be substantially as follows:

PROPOSED TAX LEVY
VILLAGE OF PERRY

Majority vote is necessary for passage.

An additional tax for the benefit of the Village of Perry for the purpose of providing funds to pay costs of rehabilitating, renovating and otherwise improving municipal roads and bridges at a rate not exceeding **one and one-half (1.5)** mills for each dollar of valuation, which amounts to **15 cents** for each one hundred dollars of valuation, for five years.

FOR THE TAX LEVY
AGAINST THE TAX LEVY

Section 4. The Chief Fiscal Officer of the Village is hereby authorized and directed to request that notice of said election be given as provided by law.

Section 5. The Chief Fiscal Officer of the Village is hereby directed to immediately certify a copy of this Resolution to the Board of Elections of Lake, County, Ohio.

Section 6. That all formal actions of this Council concerning the passage of this Resolution were adopted in an open meeting, and all deliberations of this Council, or any of its committees, which resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 7. That all Resolutions or parts thereof in conflict with the provisions of this Resolution are hereby repealed.

Section 8 That this Resolution constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the Village of Perry.

Wherefore, this Resolution shall be in full force and effect immediately upon its passage.
